**2. CONDITIONAL USE PERMIT NO. 938
PRECISE DEVELOPMENT PLAN NO. 1895**

Jose Ponce, Ponce Recycling, Inc., 11660 Firestone Boulevard; a request to establish a recycling center within the parking lot of an existing commercial center.

Staff Recommendation: That the Planning Commission:

- (1) Adopt Resolution No. 12-3 to approve Conditional Use Permit No. 938 subject to the conditions of approval contained in respective Exhibit "A"; and

(2) Adopt Resolution No. 12-4 to approve Precise Development Plan No. 1895 subject to the conditions of approval contained in respective Exhibit "A".

3. PRECISE DEVELOPMENT PLAN NO. 1898

Dr. Lowell Smith, 11936 Imperial Highway; a request to relocate an optometrist office to an existing multi-tenant office development and adjust the required parking through the approval of a parking study.

Staff Recommendation: That the Planning Commission adopt Resolution No. 12-10 to approve Precise Development Plan No. 1898 subject to the conditions of approval contained in Exhibit "A".
