

3. UNCLASSIFIED USE NO. 15

Michael Kerwin, National Tooling and Machining Association (NTMA) Training Centers of Southern California; a request to determine that a machining, tooling, and manufacturing training center is substantially similar to, and not more obnoxious or detrimental to the public health, safety and welfare than, a business college, and shall be subject to the same requirements and process.

Staff Recommendation: That the Planning Commission adopt Resolution No. 12-17, denying Unclassified Use No. 15.
