**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

**Applicability.** Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

**Definitions.**

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

The City of Norwalk has aging housing stock, high rents, and limited multifamily housing choices. As such, project-based vouchers are an appropriate option for the City to facilitate the development of new rental housing or projects that create new housing opportunities for special needs populations, particularly for homeless or disabled individuals. Additionally, project-based vouchers are a tool for preserving affordable housing that is at risk of converting to market-rate housing. Project-basing voucher is consistent with the 5-year PHA Plan as it is one of the strategies listed in the Plan to address housing needs through the preservation and/or development of affordable housing.</p>

However, the Authority secured HOME funding to assist new voucher holders with the payment of security deposits.</p> <p><b>Goal #2:</b> Maintain high performing status.  <b>Progress:</b> The Housing Authority's received a high performer designation by HUD for its performance in FY 2015/16.</p> <p><b>Goal #3:</b> Maximize leasing and budget utilization.</p>

	<p><b>Progress:</b> Due to rising rents, the Authority will utilize over 100% of its budget authority and 97% of its vouchers in CY 2016.</p> <p><b>Goal #4:</b> Promote economic self-sufficiency among program participants.  <b>Progress:</b> The Authority continues to administer the Family Self Sufficiency (FSS) program with 25 slots. The Authority applied for and received CY 2017 FSS Grant funding. The Authority maintains partnerships with the Southeast Los Angeles County Private Industry Council – Workforce Investment Board, Cerritos College, and the Norwalk-La Mirada Unified School District. Information about job opportunities, training, job fairs, and scholarships are shared with FSS participants throughout the year.</p> <p><b>Goal #5:</b> Undertake affirmative measures to provide a suitable living environment for families living in assisted housing, regardless of race, color, religion, sex, familiar status, and disability.  <b>Progress:</b> The program is promoted to all segments of the Norwalk population. Housing Quality Standards are applied equally to all units regardless of location or family type. The Authority adopted policies giving more housing search time to disabled households and reviews reasonable accommodation requests on a case-by-case basis. The Authority works closely with the Fair Housing Foundation to assist participants with fair housing issues and to provide fair housing training to landlords. The Housing Authority also participated in the development of the City’s 2015 Analysis of Impediments to Fair Housing Choice.</p>
