It's that time of year, when our community demonstrates the spirit of the season with lights and ornaments of all colors, shapes and sizes. The City of Norwalk Community Promotion Commission invites residents and merchants to enter our Holiday Home & Business Décor Contest.

Entries are not required to be self-nominations. Participants may nominate other individuals' homes or businesses. Nominated parties must be Norwalk residents or Norwalk business owners/managers.

Contest winners will be chosen in three categories: Best Display-Residential, Best Display-Business, or Best Group Entry. Winners will be recognized at a City Council meeting and will receive a festive yard sign commemorating their award.



Best Display-Residential and Business

Lighting, garland, decorations, inflatables, or animated sculptures installed with care and taste reflect the magic and joy of the holidays. Winners will be selected based upon creativity, theme and visual appeal.



Best Group Entry

Groups of three or more consecutive homes (or business spaces) decorated in a unified theme may enter together.

Important to note: All décor must be exterior only and visible from the public right of way. Decorations should be safely installed and maintained.

Community Promotion Commissioners will be visiting nominated properties December 18 through 29 after 6:00 p.m.
